By subscription of \$50 each, on or before April 1, 2005 or by supplementary nomination of \$3,500 each by closing time of entries. \$100 to start. Weights: Three year olds 118 lbs.; older 124 lbs. Non-winners of a race other than maiden, claiming or starter allowed 2 lbs.; non-winners of a race other than claiming or starter, 4 lbs. (Winners that have started for a claiming price of \$25,000 or less in their last 3 starts and maidens that are non-starters for a claiming price have second preference).

Horses which have finished 2nd or 3rd in a non-claiming race in at least one of their last 3 starts preferred. Second preference will be given to non-starters for a claiming price. Third preference will be given to horses which have finished 2nd or 3rd for a claiming price in one of their last 2 starts.

Non-winners of a race other than maiden, claiming or starter allowed 2 lbs.; non-winners of a race other than claiming or starter, 4 lbs. (Winners that have started for a claiming price of \$25,000 or less in their last 3 starts and maidens that are non-starters for a claiming price have second preference).
